Dear Sir/Madam:

This letter will serve to inform you of the wage rates for the period **December 29, 2021 through June 30, 2022**

The following is a listing of the steamfitter's hourly wage rate, fringe benefit contributions and payroll deductions. The Work Dues, Additional Work Dues, Enhancement Fund, Target Fund and the Building Fund are deductions from the steamfitter's net pay. Wages and fringe benefits are time and one half for overtime.

For the next rate period, the percentage level fringe benefit contribution rates are to be adjusted as follows;

Welfare Fund:	\$0.44 (payable directly to Local 669)
Wages:	-\$0.22
Supplemental Retirement Fund:	-\$0.22
Total:	<u>\$0.00</u>

The Welfare Fund contribution rate charged by Local 669 has been increased by \$0.44 per paid hour effective January 1, 2022. Since there is no contractual increase to Local 638, a reduction was made to wages and the Supplemental Retirement Fund in the amount of \$0.22 each, per paid hour. Furthermore, funds have been reallocated from the Pension Fund to the Supplemental Retirement and the Security Benefit Fund for level 3 members.
